

Home inmate found hanging

Howrah: A 17-year-old inmate of the state-run SMM Home in Liluah, Howrah, was found hanging inside a bathroom late on Saturday evening, resurrecting images of the institution's past notoriety. The girl, a resident of Howrah's Nilmoni Sarkar Lane, was rescued from Kerala in May this year.

Home authorities said she was depressed for the last few days after being ill-treated by some senior inmates.

"The girl was ambitious and wanted to stand on her own feet. In the past, she ran away from home on two occasions in search of jobs. Even this year, she ran away to Kerala after a

local youth offered her a job there. Her parents lodged a missing complaint. When the police traced her to Kerala, they came to know that she was being sexually abused. She was sent to the home on May 25 as she was a minor. Even her parents wanted her to stay there and undergo counseling," police

said.

Some senior inmates started mocking her for planning to make a living through honest means. Even her parents have complained to police against the inmates. "Though it seems to be suicide prima facie, we are awaiting the autopsy report," said J A Kidwai, DC (north), Howrah City Police.
